HALL OF FAME AWARD APPLICATION

The highest award which the ARBA can bestow is induction into the ARBA HALL OF FAME. This award will be given to members whose contributions to the rabbit or cavy industry excel beyond our other awards. Applicants should be worthy of this recognition by having major accomplishments at the national level.

The nominee should have already been recognized by receiving all awards available at the local, state, or regional level.

Following is a list of general criteria for the issuance of this award. The nominee should meet most of the guidelines as specified to qualify for the award.

The nominee should:

- be an ARBA member in good standing.
- have been an ARBA member for at least 10 years.
- have outstanding accomplishments in several areas of national level work with clubs or individuals.
- have been an officer at local, state, and national level over a span of years.
- have helped organize or been an active participant in a national conference.
- have published articles in magazines or news bulletins that have been of benefit to the industry.
- have demonstrated the ability to raise and exhibit animals successfully at all levels.
- have donated unselfishly of time, effort, or finances to benefit the rabbit and/or cavy industry.
- have served actively as a judge and/or registrar in a positive manner to promote the industry.
- have accomplishments which invoke recognition by the mention of his/her name.
